2024 Program Objectives

- Learn techniques for gonioscopy, particularly in eyes where the view is confusing.
- Recognize that some forms of glaucoma are strongly inherited and may have specific effective treatments.
- Understand the role of trabeculectomy in glaucoma management and learn surgical pearls to make the surgery safer and more effective.
- Develop customized treatment plans for individual patients, setting a target pressure and making realistic interventions.
- Learn current and best practices of periocular rejuvenation, periocular lesions and eyelid malposition practices to optimize outcomes and provide safety for the patient.
- Learn to assess patients with periocular lesions and other anomalies. Develop a
 differential diagnosis and identify management options for each patient.
- Learn to consider vitreoretinal lymphoma under the appropriate clinical setting and identify the diagnostic testing that is needed to secure a firm diagnosis.
- Recognize that viruses are an important etiology in anterior uveitis. Learn about helpful clinical clues and when to consider anterior chamber paracentesis for directed nucleic acid amplification testing.
- Ability to perform a complete work-up and treat all cases of optic neuritis.

- Learn about the progress being made in understanding how pathogens and/or gene transcription products can give insights into more precisely characterizing ocular inflammatory disorders. Identify scenarios where additional molecular testing may be indicated for patient care.
- Identify helpful tests and questionnaires in order to recognize different subtypes of dry eye. Learn what therapies may be most suitable depending on dry eye subtype.
- Learn ability to diagnose and treat ocular myasthenia gravis.
- Learn to assess stroke risk factors and activate stroke pathway evaluations in patients with transient vision loss.
- Learn when to suspect secondary causes of primary headache and initiate corresponding work-ups in order to avoid potential neurologic deficits and excessive testing.
- Learn about the conditions that contribute to safety protocol failures, and ways to mitigate the probability of those failures; the role of informed consent and documentation of patient care in defending a claim; and the principles of disclosure of unanticipated events and human error.

Oculoplastics



WENDY LEE, MD

Wendy W. Lee, MD, MS, is Professor of Clinical Ophthalmology and Dermatology at the Bascom Palmer Eye Institute at the University of Miami Miller School of Medicine. She serves as director of the Bascom Palmer Aesthetic Center and co-director of the university's Cosmetic Medicine Group, a multidisciplinary group comprised of the ophthalmology, dermatology, ENT, and plastic surgery departments.

Dr. Lee earned her medical degree from Tulane University School of Medicine, in New Orleans, Louisiana, and a Master of Science degree in physiology from Georgetown University in Washington, DC. She completed both her residency and internship at Tulane, and a fellowship in ophthalmic plastic and reconstructive surgery at the Bascom Palmer Eye Institute.

Dr. Lee conducts research at the Bascom Palmer Eye Institute with special interests in eyelid reconstruction, the aging eyelid skin, and aesthetic lasers. She also lectures around the world on oculoplastic disorders and aesthetic treatments related to the eye. She's been published extensively, both in peer-reviewed journals and in teaching text books. She also serves as chief medical editor for *FacialAestheticsCE* and as a section editor for *Ocular Surgery News*.

Dr. Lee serves as a key opinion leader for many aesthetic and functional companies. She has received the Achievement Award from the American Academy of Ophthalmology, The Henry Baylis Award for Excellence in Cosmetic Surgery from the American Society of Ophthalmic Plastic and Reconstructive Surgery, Professor of the Year Award from the residents at Bascom Palmer Eye Institute, Outstanding Alumnus from the Tulane University Department of Ophthalmology and was featured on CNN for her charitable work on patients from developing countries, among other honors.

Neuro-Ophthalmology



PETER QUIROS, MD

Dr. Quiros obtained his MD from The Yale University School of Medicine. He trained at the Los Angeles County Hospital/ University of Southern California residency training program and then proceeded to complete his neuro-ophthalmology fellowship at the Doheny Eye Institute.

Dr. Quiros was on the faculty at the University of Southern California for over a decade, where he was the Residency Program Director. He is currently Associate Professor at the University of California, Los Angeles and Director of the Neuro-ophthalmology Fellowship Program as well as Chief of Service for Neuro-ophthalmology, Orbit and Oculoplastics for Doheny Eye Centers UCLA.

Dr. Quiros served as Associate Secretary, English-language Region for the Pan-American Association of Ophthalmology (PAAO) from 2005 -2011 and Vice-President of the organization from 2011-2013. He is currently the Secretary of the North American Neuro-Ophthalmology Society. He has been working with the PAAO and International Council of Ophthalmology (ICO) to improve the quality of residency education through the Educating the Educators teaching program. He is currently the Director of Curricula and Expectations for Training Programs for the International Council of Ophthalmology. Dr. Quiros has been recognized internationally for his contributions to the future of residency education and is a recipient of the ICO Mark Tso Golden Apple Award for Medical Educators.

Glaucoma



WALLACE L.M. ALWARD, MD

Wallace L.M. Alward, M.D. is Professor Emeritus at the University of Iowa, where he was the Director of the Glaucoma Service from 1987 to 2020. Dr. Alward has co-authored more than 150 peer-reviewed papers that have been cited over 12,000 times. The primary focus of his research has been the molecular genetics of glaucoma. He and his colleagues first described several glaucoma genes including myocilin, PITX2, FOXC1, and TBK1. He has authored two textbooks (*Color Atlas of Gonioscopy* and *The Requisites: Glaucoma*) and one iBook (*The Iowa Glaucoma Curriculum*). He maintains two websites: one to teach gonioscopy (www.gonioscopy.org) and an introduction to glaucoma for residents (http://curriculum. iowaglaucoma.org). Dr. Alward served as a Director of the American Board of Ophthalmology from 2006 to 2013 and was Chair in 2012. In 2016 he received the inaugural Educator Award from the American Glaucoma Society. He has given 26 named lectures including the Hans Goldmann Lecture of the Glaucoma Research Society. In 2022 he was the Guest of Honor of the American Glaucoma Society.

Uveitis



JOHN GONZALES, MD

Dr. Gonzales is an Associate Professor of Ophthalmology at the Francis I. Proctor Foundation at the University of California, San Francisco specializing in uveitis and medical cornea. He has been supported by an early career award from the National Institutes of Health – National Eye Institute to study the spectrum of keratoconjunctivitis sicca in Sjögren's syndrome utilizing the Sjögren's International Collaborative Clinical Alliance (SICCA) cohort. Dr. Gonzales is also the PI for an international randomized clinical trial evaluating treatments for cytomegalovirus anterior uveitis in immunocompetent individuals. Dr. Gonzales's interests also extend to ocular oncology, specifically primary vitreoretinal lymphoma, and he is interested in how clinical features may be correlated with mutations associated with lymphoproliferation as well as resistance to chemotherapeutics.

Dr. Gonzales is a Section Editor for *Current Opinion in Ophthalmology*, Associate Editor for the *Journal of Ophthalmic Inflammation and Infection* and is the uveitis fellowship program director at the Proctor Foundation.

LINDA HARRISON, PHD

Linda Harrison is the VP of Risk Management at OMIC. Dr Harrison has lectured nationally on topics in health care risk management, litigation stress syndrome, physician burnout, and negotiation strategies. She also leads efforts to improve organizational effectiveness through process analysis, re-engineering and implementation, team building, and coaching.

Dr. Harrison received her AB from Smith College, her master's in Psychology and Human Development from Harvard, and PhD in Organizational Psychology from the California School of Professional Psychology.
